

## Waiver / Rental Contract

The payment of the deposit or any partial or full payment for products or a reservation on a rental and its associated services shall constitute consent to all provisions listed under "Ramo Pro Cycling European Bicycle Tours & Rental Terms & Conditions" herein. These provisions are hereby incorporated by reference in this RESPONSIBILITY notice, and participants are advised to take notice.

- 1. Ramo Pro Cycling Bike Rental is the principal bicycle rent operator for these rentals and is responsible to the participants for all rental arrangements and for all services offered.
- 2. Bicycles provided for rent are in satisfactory operating condition and participants agree to use them at their own risk or call deficiencies to the immediate attention of the Ramo Pro Cycling. Instruction in the use of bicycles will not be provided and participants affirm that they are familiar with the use of a multi-speed bicycle.
- 3. Ramo Pro Cycling reserves the right to substitute bicycles with comparable bicycles if necessary. The right is also reserved to decline to accept or retain any person as a renter due to circumstances beyond the control of Ramo Pro Cycling.
- 4. Bicycle renters accept the following conditions:
- Bicycle renters are required to wear a helmet while cycling.
- Renters understand that bicycles are rented without safety devices such as **lights** (and so can only be ridden from sunrise to sunset) and **bells** (and so must use other auditory signals while bicycling).
- Renters agree to abide by all national rules of the road while using the bicycle/s, including the new laws forbidding
  cycling while under the influence of alcohol and cycling while using a cellular phone. Renters are responsible for
  paying for any infraction of the Cypriot rules of the road, including any costs resulting from impoundment and
  subsequent retrieval of the bicycle/s.
  - 1) I hereby <u>declare</u> that I and everyone using the bicycle(s) I am now renting have the necessary experience to use it/them, and that I have tested and checked its/their perfect working condition.
  - 2) I will notify Ramo Pro Cycling immediately of any eventual malfunctions or breakages of the bicycle(s). I <u>declare</u> that the bicycle(s) will not be used improperly and that I will personally redeliver it/them to Ramo Pro Cycling or their local agent or will make confirmed written arrangements as to the return of the bicycles.
- 3) I am providing Ramo Pro Cycling with a refundable deposit of €100 in cash, for precautionary use only. I authorize Ramo Pro Cycling to charge from the amount mentioned above for any cost in case of damages to the bicycle(s) during my rental period, comprehensive of labour, except in the case that I can demonstrate other's faults with evidence and all necessary information for reimbursement. In case of theft, I will be responsible for reimbursing Ramo Pro Cycling for the original purchase price of the bike, plus the cost of any accessories that were provided at the time of the bike rental.
- **4)** I agree to not hold Ramo Pro Cycling, its operators, agents, servants and employees responsible for personal injuries or property damage, loss or delay, or change of itinerary incurred by any person or renter arising out of the act of negligence of any direct or supplemental carrier, or other person rendering any of these services, nor shall Ramo Pro Cycling be responsible for any injuries, death, damage, loss or delay in any means of transportation or by reasons of any event beyond the actual control of Ramo Pro Cycling or of any agent or supplier.
- **5)** I understand that Ramo Pro Cycling requires members of my party to **wear a helmet** while cycling and that bicycles are provided without safety devices such as **lights** (and so can only be ridden from sunrise to sunset) and **bells** (and so must use other auditory signals while bicycling).
- **6)** I understand that all members of my party are required to abide by **national rules of the road**, including not cycling while under the influence of **alcohol** and not cycling while using a **cellular phone**. Any infractions to the national rules of the road are my responsibility, including paying fines, fees or bicycle impoundment costs for retrieving the bicycle/s.
